Rich and Julie Stewart presented their proposed plans for 109-a 10.9 acre lot on Mirror Lake Road J-Lot 109 Tax Map 403), which they are considering purchasing. Jo Beth told-themsuggested they contact the Planning Board and should-present their plan to theat the next regular Planning Board at the meeting next-week. Lot 109 Tax-Map 40 The Stewarts' propose a retreat facility for Veterans and their families recovering from PTSD. They envision their house, plus up to five Parkview type trailers, all ADA compliant and covered with log siding, for the quests. A small office/welcome center building is also planned. The Select Board noted that the state is responsible for all septic system and waterfront/wetlands permitting, and that all state building codes would apply.
