Jo Beth made a motion to put the dog ordinance on the ballot. Carol seconded the motion. Motion passed unanimously by roll call vote.

Jo Beth made a motion to go into a Non-Public session at 8:20 pm. Carol seconded the motion. Motion passed unanimously by roll call vote.
