Horizon Engineering was asked about Eastern Analytical's report regarding the old Dalton Landfill. They will complete the report that provides an explanation of Eastern Analytical's findings and we will be provided a copy of the report once it's ready to submit to NH DES.

Katie with Certified Computers will be present at the January 8, 2024 meeting to discuss IT security and computer program options recommended for 2024.

Jo Beth asked how the speed monitoring equipment use was going. Jeanette confirmed all was going well and that the town is receiving additional patrolling hours from Troop F just for the speed issues. Since Dalton received the monitoring units through the grant, these hours come to Dalton free of charge because Troop F receives federal grant funds for this purpose Tom mentioned the sign flashing blue and red when he was doing the speed limit. Vic St. Cyr mentioned it happened to him as well. Jeanette will check the signs' programming when they're brought back in for charging.

Jeanette will send out additional RFPs for a new Assessor for 2024 forward. To date, there have been no proposals received for a new assessing contract.

Jeanette let the Board know that Casella wanted to come in and present a status on the proposal GSL project. The presentation has been scheduled for Working Session scheduled for Monday, January 15, 2024. This will be a presentation only, with no public questions or comments.

December 8th meeting was a recap of previous meetings, bring up to speed of the process. Several questions were asked regarding if the lines will be fiber. Response is fiber to the premises and for Dalton about 443 premises. Inquired if this includes campgrounds, and fiber is going to the point of the main entry, from there the campground disperses with their services. Did learn that unincorporated locations would not be receiving fiber.

Once the fiber lines have been placed, they will move to discussions directly with the town specifically.

AS of December 4th, fiber was being placed on poles in Dalton on Blakslee Rd and various other points in Dalton. For the last 2 weeks, our home has been receiving calls regarding future Fiber connection being available.
