Jon Swan discussed GSL updates, including the landfill moratorium bills, as well as the response/expected response from Casella for the Solid Waste/Wetlands/AoT applications

Jon Swan also discussed the ongoing DCC appeal of the GSL Shoreland Impact Permit approval with the NH Wetlands Council

Carol Sheltry motioned to authorize Orr and Reno to file any appropriate appeals should the Wetlands Council dismiss the DCC appeal for standing, etc., Ernie seconded the motion, motion passed unanimously

A discussion ensured about continuing with the UNH Speaker Topics in 2025, as the Whitefield CC meets in April and will get back to us about working jointly on hosting one, or more, potentially at the Whitefield Public Library in order to have more community engagement. There was also discussion about reaching out to Littleton and Bethlehem CCs as well for future events

The Dalton Roadside Cleanup will take place on Saturday April 26th, from 9am-12 noon, with a BBQ to be held at the Fire Department, possibly in conjunction with the Dalton Neighbors group. A trailer for bag pickup is also needed, and a blue bag tally was conducted. Jon Swan will reach out to NRRA to obtain another box of free blue bags.
