Host Community Agreement Survey

The Town of Dalton elected a committee to assist the Selectboard in negotiating a host community agreement with the landfill proposed to be established by Casella Waste Management should permits for construction and operation be obtained at the State level. As part of the Host Community Agreement Committee's desire to understand the wants and needs of Dalton's residents, relative to the agreement with Granite State Landfill, we ask you take a few minutes and fill out the following survey which is comprised of two parts. The first is a list of items relative to environmental concerns and financial concerns (other than the annual revenue payment) which we ask you to indicate how important each item is on a scale of important, somewhat important and not important. The second part pertains to what your preference is for how the town would receive an annual revenue payment from GSL.
